### Board Resolution Letter Sample for Removal of Authorised ...

A board resolution (bank employees will often call it "BR") is a resolution passed in a Board Meeting authorizing certain persons in a company to open and operate the bank account of a Company (Private Limited or Public Limited) or Limited Liability Partnership (LLP). A company is considered a separate legal entity (consider it as another person), the board resolution is required for opening a bank account in addition to other documents.

### How To Draft A Board Resolution To Open A Bank Account ...

A corporate resolution is a formal declaration made by a board of directors that officially records specific decisions that are material to a business. These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

RESOLVED, that the following Officers and/or Directors of the Corporation are authorized to sign or endorse checks, drafts or other evidences of indebtedness made payable to the Corporation for the purpose of deposit into the Corporation's account.

The bank be & is hereby requested and instructed to honor all documents including L/C, drafts, orders, Cheques issued by the company when signed jointly upon the above signatory, c. RESOLVED FURTHER, That the President, Vice-President, Secretary or Treasurer of this corporation, or either of them, be, and they are hereby authorized and empowered to certify and deliver to the said bank a copy of this resolution, and to execute a proper signature card, or cards, bearing the authorized signatures as aforesaid, and to execute and deliver to said bank subsequent cards bearing the specimen signatures of such others as may from time to time hereafter be authorized to sign the ...

### Account Signatories - Free Legal Forms

Specific Authorisation: In some cases, the board of directors can also authorise any director or official of the company to sign a specific agreement with a specific party on a certain case by passing a board resolution. ### SAMPLE RESOLUTION LETTER - Old Mutual

Bank account signatory is a person who is authorised through a board of directors' resolution passed in a board meeting to operate a certain bank account. Bank account signatory can sign the cheques etc to complete the day to day finance activities. Most of the companies appoint joint signatories to handle a company bank account one: from account department and second may be some senior finance level employee.

### Procedure for change in bank account signatory of a company
